INTRODUCTION

- o Now that we've talked about research articles and summarizing research results, it's time to learn how to reference and cite these articles, and to access tutorials when needed.
- o I will also show you a process for checking the format of your references, and we will use this process to make a reference list.
- o We will focus on journal articles and online government reports, two of the most common sources in public health.

Citations occur in the text, and name only the author(s) and date.

References are listed at the end, and include all information needed to find the original source.

Steps for checking your references

- o When you're taking interactive notes, you can copy and paste the reference information without worrying about the formatting
- o However, a common mistake that students make is to copy this information directly into their reference list with only minor changes
- o Reference information comes to you in many different formats, so you need to transform all of your references into APA style

Steps for checking your references

- o Editing each reference one at a time while looking at an APA style guide is extremely tedious and prone to errors
- o The key to creating an accurate reference list is being systematic in your editing of the whole list together, by editing one kind of thing at a time (e.g., just the author names in each of your references)

Steps for checking your references

Here are four steps that make this process more systematic:

- o Copy and paste the *reference parts* onto a list
- o Format the list with ½ inch indentation
- o Format just one *reference part* at a time, all the way down the list
- o Alphabetize the list

- o Author last name/initials + year + article title + journal name + volume + issue + pages

The order of reference parts

Many recent journal articles have a DOI (digital object identifier) to make it easy to find them online.

The order of reference parts

Journal articles in Public Health often have many authors.

Order of reference parts:

- o First six authors' last names/initials + last author name/initials + year + article title + journal name + volume + pages

The order of reference parts

We often cite government reports or web pages that are published online.

Nonperiodical web document, web page, or report:

- Angeli, E., Wagner, J., Lawrick, E., Moore, K., Anderson, M., Soderland, L., & Brizee, A. (2010, May 5). General format. Retrieved from <http://owl.english.purdue.edu/owl/resource/560/01/>

Order of reference parts:

- Authors' last names/initials + date published [year, month day or n.d. if no date] + article title + web page link (this is not a periodical, so web page link is needed)

The authors of web reports are often government agencies.

- There is no date when this was posted online, so you don't need it. It is an agency report, not a journal article, so there is no journal/volume/issue information. Don't forget the first part of the title: "Women and HIV/AIDS" which is at the top of the page, but not in the main body.

It is not ok to put: Agot KE. It has to be Agot, K. E. The second list did not include all the names, so I used the first list.

Using APA for citations

- o Although many public health and medical journals are using Vancouver style, almost all professors are asking for APA style in your papers.
- o The Purdue OWL link tells you what you need to know about: citing at the beginning vs. end of a sentence, citing multiple authors, citing organizations, and citing reports with no date.

Using APA for citations

- o Citing at the beginning of a sentence:
Research by Wegener and Petty (1994) supports...
[Note and]
- o Citing at the end of a sentence:
...(Wegener & Petty, 1994). [Note &]
- o Citing up to five multiple authors the first time:
(Kernis, Cornell, Sun, Berry, & Harlow, 1993)
- o Citing multiple authors if more than six, or after the first time:
(Agot et al., 2010) [Note the format of et al.]

- o Citing organizations the first time:
According to the Environmental Protection Agency [EPA] (2000), ...
- o Citing organizations after the first time:
According to the EPA (2000), ...
- o Citing reports with no date:
(UNAIDS, UNFPA, & UNIFEM, n.d.)
